# **Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies to www.no-more-pain.info, and No More Pain Herbal Blends, Inc. and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to No More Pain Herbal Blends, Inc. include www.no-more-pain.info and No More Pain. # **Collection of your Personal Information**
